

Tuition Fee Reduction Information 2026-27

GENERAL INFORMATION

A reduction of the Tuition Fee may be possible for families who pay school fees privately and are otherwise not able to afford the full school fees. Families who pay school fees privately and who do not meet the eligibility requirements for a reduction of the Tuition Fee can request to pay in 10 instalments. All applications and the related financial information are dealt with on a strictly confidential basis within the school management.

The following conditions and pre-requisites apply:

- A reduction can be offered only to families who receive no reimbursement or financial assistance for school fees from an employer.
- If parents cannot afford to enrol or re-enrol a child in spite of a Tuition Fee reduction offer, a refund of €100 of the Administration Fee is possible.
- A reduction of the Technology Fee, IB DP Pamoja online course fees or DP examination fees cannot be offered.
- A Tuition Fee reduction cannot be combined with the *Long-term Enrolment Tuition Fee Reduction* option.
- A Tuition Fee reduction cannot be combined with the *Sibling Tuition Fee Reduction* option.
- A Tuition Fee reduction is applicable for one year only. Families must apply for a reduction annually at the time of re-enrolment.

Eligibility for a Tuition Fee reduction is determined according to the following chart; the term "Total Annual Family Income" refers to the total amount of family income according to the German income tax assessment ("Gesamtbetrag der Einkünfte") which includes all other sources of income such as capital gains or income from abroad.
